Subject: Daycare & Lunch Fees

Dear Parents/Guardians,

These are the details concerning the **fees payable** for either the Lunch Program or the Daycare Program. Access to daycare will be denied to parents with an outstanding amount from last school year. *If paying by cheque please issue your cheques to St. John Fisher Junior Daycare.* Make sure to write your child’s name on the front or back of **each** cheque. **Once you have received your first statement of account you will be able to proceed with online payments, if this is the option you have chosen, as per the schedule below.**

Additional charges: Pedagogical days are charged separately at a rate of \$10.00 for 10 hours of supervision plus any activity/supply fees. We have an average of 9 ped days per school year. If your child attends all the ped days at the maximum cost of \$25.00 per child per ped day, you can predict that you will spend \$225.00 per child for ped day attendance. Our daycare is closed during all Holidays as well as two professional days for staff, in November and the Tuesday following Easter weekend. Priority is given to children registered in the daycare.

Late fees are \$1.00 per minute per child after our closing time of 6:00 p.m.

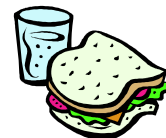
To cover your **daycare fees, \$8.20 per day**, if paying by cheque, please provide us with post dated **cheques for the months of September through to December. In January please send us the rest of your postdated cheques, January to May, according to the rate confirmed at that time. Your June invoice will be processed in the middle of May and we will request your final payment by mid-June.** Please follow the chart and make your payments for the amounts listed under the 5 days; 4 days; or 3 days per week columns. Included in the 4 and 3 days per week fees are the additional fees of \$2.00 per day we charge for the 1 or 2 days that your child attends the lunch program only. Your actual invoice might vary from the 4 or 3 day per week amounts shown as it depends on which days of the week your child is registered to attend. Adjustments, if needed will be made in June 2018. If you have more than one child at the **Junior** school you may combine them on one cheque or one online payment.

To cover your lunch program supervision fees, if you are **not** using the daycare, please provide us with your payments, according to the chart below. Please make sure your payments are received before the end of each month. You may also use the online payment option. Please make sure to indicate your child's name on either the front or back of **each** cheque. If you have more than one child at the junior school you may combine them on one cheque or one online payment.

Our annual fee is \$360.00 per child for supervision during the lunch hour, for students **not** registered in the daycare program.
